The meeting opened at 9:00 a.m. with a prayer by Bro. Jerry Manning, and the pledge to the American Flag.

The Union County Fiscal Court met in a regular scheduled meeting with Judge O'Nan presiding. Magistrates present were Wyatt, Floyd, Ricketts, Byrnes, and Clements.

Magistrate Floyd made a motion to approve the minutes from the January 29, 2019 meeting, seconded by Magistrate Ricketts, motion carried.

Jeanie Hancock presented the Court with many Congenital Heart Defect facts and explained how this heart disease has affected their family, and she want to raise awareness to help fund research. Judge O'Nan presented a Congenital Heart Defect Awareness Proclamation, proclaiming the week of February 7, 2019 through February 14, 2019 Congenital Heart Defect Awareness Week in Union County.
