The meeting opened at 9:00 a.m. with a prayer by Bother Jerry Manning and the pledge to the American Flag.

The Union County Fiscal Court met in a regular meeting with Judge O'Nan presiding. Magistrates present were Wyatt, Floyd, Ricketts, Byrnes, and Clements.

The minutes from the August 13, 2019 Fiscal Court meeting were accepted as read.

Judge O'Nan presented the one bid received for the Heavy-Duty Dump Truck from Vomac Truck Sales and Service, Inc. for \$151,250.00. Magistrate Floyd made a motion to take the bid under advisement to review and award at the September 10, 2019 Fiscal Court meeting, seconded by Magistrate Ricketts, motion carried.

Cody Baker and Byron Johnson with Road Builders advised the Court that at this point their asphalt prices are the same as their bid, and that gas prices would have to go up to \$76.00 a liquid ton for their bid price to reach Rogers Group price. Road Builders prices are looked at monthly.

Kathy Stevens with the Sheriff's office presented the 2018 Oil Tax Settlement, collecting 97.68%. Magistrate Byrnes made a motion to approve the 2018 oil tax settlement pending audit, seconded by Magistrate Wyatt, motion carried.

Judge O'Nan presented a Resolution Designating the Union County Industrial Development Authority to Receive TVA Funds under the Regional Development Agency Assistance Program. Magistrate Clements made a motion to approve said resolution, and give Judge O'Nan authority to sign any and all necessary paperwork, seconded by Magistrate Floyd, motion carried.

Magistrate Clements made a motion to set the 2020 motor vehicle and watercraft property tax rate at 11.30 cents per \$100, seconded by Magistrate Ricketts, motion carried.
