UNION COUNTY FISCAL JANUARY 14, 2020

The meeting opened at 9:00 a.m. with a prayer by Bro. Jerry Manning and the pledge to the American Flag.

The Union County Fiscal Court met in regularly scheduled meeting with Judge O'Nan presiding. Magistrates present were Wyatt, Floyd, Ricketts, Byrnes, and Clements.

The minutes from the December 17, 2019 Fiscal Court meeting were accepted as read.

The minutes from the special called December 30, 2019 Fiscal Court meeting were accepted as read.

Amelia Wilson from Congressman Comer's office was in attendance and reported that the Congressman is in support of upholding the Second Amendment. She also reported there is no change on the teacher situation in Washington. Lastly, the Congressman still has the Sturgis Airport on his list. Amelia will be back on February 25th to assist with Social Security for the VA.

Judge O'Nan read Resolution 2020-1 which was born out of the Virginia Legislatures Bill that was a strict infringement on the Second Amendment. This Resolution has rapidly moved its way across The Commonwealth of Kentucky. Union County is in strong support of upholding the Second Amendment. The Court does not was to do anything that would be punitive for Union County down the road. Judge O'Nan feels that this is the proper response at this time. He vows to spend his time in Frankfort making sure our voice regarding the Second Amendment is heard. Magistrate Clements made a motion to approve Resolution 2020-1, seconded by Magistrate Floyd, motion approved. Magistrate Ricketts stated that he stands against any infringement on our rights as written in The Constitution. Judge O'Nan told the crowd he appreciated their attendance in supporting the Second Amendment.

County Sheriff, Mickey Arnold presented the 2020 Sheriff's budget for a second reading. Receipts are in the amount of \$864,130 disbursements in the amount of \$854,500 with excess fees of \$9,630. Magistrate Ricketts made a motion to approve the Sheriff's second reading of the 2020 budget, seconded by Magistrate Wyatt, motion approved.

County Clerk, Garrick Thompson pursuant to KRS 64.530(3) requested the Fiscal Court set the 2020 maximum salaries for County Clerk Deputies at \$263,463. Magistrate Wyatt made a motion to set the 2020 maximum salaries for the Deputy Clerks, seconded by Magistrate Floyd, motion carried.

Judge O'Nan asked to set advertising dates for a new ambulance for January 15th and January 22nd, with closed bids to be opened at Fiscal Court on January 28th. Magistrate Byrnes
