UNION COUNTY FISCAL COURT MEETING October 26, 2021

The meeting opened at 9:00 a.m. with a Prayer by Bro. Jerry Manning, and the Pledge to the American Flag.

The Union County Fiscal Court met in a regular meeting with Judge Executive Adam O'Nan presiding. The Union County Fiscal Court met in the upstairs Courtroom. Magistrates present were Wyatt, Floyd, Ricketts, Byrnes, and Clements.

The minutes from the October 12, 2021 meeting were accepted as read.

Judge O'Nan presented a Proclamation stating that the month of October 2021 is proclaimed as Domestic Violence Awareness Month in Union County. Magistrate Ricketts made a motion declaring October 2021 as Domestic Violence Awareness Month in Union County, seconded by Magistrate Clements, motion carried.

Judge O'Nan presented a Proclamation stating that the month of November 2021 is proclaimed as Diabetes Awareness Month in Union County. Magistrate Byrnes made a motion declaring November 2021 as Diabetes Awareness Month in Union County, seconded by Magistrate Ricketts, motion carried.

Kim Humphrey and Ken Ford with Riverview Coal presented the Fiscal Court with their 2021 Property Tax check in the amount of \$1,969,003.

Union County Clerk, Garrick Thompson, came before the Court to make them aware that since there is no value to our old voting equipment, it will be declared as surplus. In doing this, he is hoping it will eliminate the recycle fee of \$2,130.00 that was included on the quote for our new equipment. Magistrate Wyatt made a motion to approve declaring the old voting equipment as surplus, seconded by Magistrate Floyd, motion carried. Clerk Thompson stated that our new equipment should be here in the next week or two and that we should know the exact amount we will be receiving from the State to put towards this new equipment on November 16, 2021.

Magistrate Floyd stated that after meeting with Chief Josh Girten of the Uniontown Water Rescue Department, in regards to the renovation cost of their building, Girten felt that if they were to receive \$20,000-\$25,000 from the Court, it would cover these expenses since they are going to do all the work that they are able to do themselves. Magistrate Floyd made a motion that the Court approve giving the Uniontown Water Rescue Department \$25,000 for renovations to their newly purchased building, seconded by Magistrate Clements, motion carried. Floyd also stated that the Nally's had left a compressor in the building for the Water Rescue Department to keep which is very much appreciated.

Judge O'Nan asked the Court for their approval for his elected officials training pay in the amount of \$4,372.96. Magistrate Ricketts made a motion to approve this expenditure, seconded by Magistrate Floyd, motion carried.

Magistrate Clements made a motion to approve the September Treasurer Report, pending audit, seconded by Magistrate Wyatt, motion carried

Magistrate Floyd made a motion to approve the Quarterly Treasurer Report, pending audit, seconded by Magistrate Ricketts, motion carried

Magistrate Clements made a motion to approve transfers, seconded by Magistrate Floyd, motion carried.

Claims are to be paid as presented.

There being no further business to come before the Court, a motion to adjourn was made by Magistrate Ricketts, seconded by Magistrate Byrnes, motion carried.
