UNION COUNTY FISCAL COURT MEETING February 22, 2022

The meeting opened at 9:00 a.m. with a Prayer by Bro. Jerry Manning, and the Pledge to the American Flag.

The Union County Fiscal Court met in a regular meeting with Judge Executive Adam O'Nan presiding. The Union County Fiscal Court met in the upstairs Courtroom. Magistrates present were Wyatt, Floyd, Ricketts, Byrnes and Clements.

Judge O'Nan presented a proclamation, proclaiming February 19-26, 2022 as National FFA Week in Union County. Magistrate Clements made a motion t approve said proclamation, seconded by Magistrate Floyd, motion carried.

Magistrate Wyatt made a motion to advertise for a part-time 911 Dispatcher on March 2, 2022 and March 9, 2022, seconded by Magistrate Ricketts, motion carried.

Judge O'Nan presented the Sheriff's 2021 Budget Amendment with an overage amount of \$42,997.12. Magistrate Floyd made a motion to approve said Amendment, seconded by Magistrate Ricketts, motion carried.

Judge O'Nan presented three vehicles from the Senior Citizens that needed to be listed as surplus:

- 2003 Green Ford Windstar
- 2010 Black Chrysler Van

Magistrate Wyatt made a motion to approve said surplus, seconded by Magistrate Byrnes, motion carried.

Magistrate Floyd made a motion to re-set Advertisement Bid Date for the Road Truck for March 2, 2022 and March 9, 2022 and to open bids on March 22, 2022, seconded by Magistrate Byrnes, motion carried.

At our February 8, 2022 Fiscal Court Meeting Judge O'Nan had an open discussion with the Court regarding the Jailer's salary and asked if they would be ready to vote on this at today's meeting? The Court assured him that they would be ready. At this time Judge O'Nan answered a question that was brought up at the last meeting: Once a salary has been set, can it be adjusted within the term? The Judge said that it could not be changed other than by the State's CPI. Judge

O'Nan then recommended setting the Jailer's salary at \$58,000. Magistrate Ricketts made a motion to approve said recommendation, seconded by Magistrate Wyatt motion carried. Magistrate Clements voted NO, stating that he felt that was too much starting out. Magistrate Wyatt said that this job is a big responsibility and that if we want good workers, we have to pay them.

Magistrate Floyd made a motion to approve the elected officials training hours, which are:

Judge O'Nan recommended cancelling the March 8, 2022 Court meeting due to a conflict with conferences and scheduling a Special Called Meeting on Friday, March 11, 2022 at 9am. Magistrate Floyd made a motion to approve said recommendation, seconded by Magistrate Ricketts, motion carried.
