## UNION COUNTY FISCAL COURT MEETING December 21, 2022

The meeting was called to order by Judge Executive, Adam O'Nan at 11:00 a.m. with a Prayer and the Pledge to the American Flag.

The Union County Fiscal Court met in a Special Called meeting with Judge Executive, Adam O'Nan presiding. The Union County Fiscal Court met in the upstairs Courtroom. Magistrates present were Wyatt, Floyd, Ricketts, Byrnes.

The minutes from the December 13, 2022 Fiscal Court meeting were approved as read.

County Clerk, Garrick Thompson presented a 2022 Budget Amendment, amending line #62 Office Equipment from \$12,000 to \$6,000 and Line #45 Record Preservation from \$6,000 to \$12,000. Magistrate Wyatt made a motion to approve the 2022 Count Clerk's Budget Amendment, seconded by Magistrate Byrnes, motion carried.

County Clerk, Thompson then presented his 2023 Budget with estimated receipts of \$6,070,125.00, estimated total disbursements of \$5,919,243.06 and estimated excess fees of \$150,881.94. Magistrate Ricketts made a motion to approve the County Clerk's 2023 Budget, seconded by Magistrate Floyd, motion carried.

Magistrate Wyatt made a motion to set the Annual order Setting the Maximum Amount for County Clerk Deputies and Assistants in the amount of \$263,463.00, seconded by Magistrate Floyd, motion carried.

Judge O'Nan presented Resolution 22-08 Approving Bonds for Sheriff. Magistrate Floyd made a motion to approve said Resolution, seconded by Magistrate Ricketts, motion carried.

Judge O'Nan presented Resolution 22-06 Approving Bonds for County Officials. Magistrate Ricketts made a motion to approve said Resolution, seconded by Magistrate Byrnes, motion carried.

Judge O'Nan presented Resolution 22-07 Approving Bonds for Constables. Magistrate Wyatt made a motion to approve said Resolution, seconded by Magistrate Byrnes, motion carried.

Judge O'Nan stated that we are doing a lot of high lift jobs on ladders, which is not a very safe practice. He recommended that the Court approve the purchase of a scissor lift that will fit through our doors so that it could be used inside and outside. Three quotes were presented:
