UNION COUNTY FISCAL COURT MEETING August 8, 2023

The meeting opened at 9:00 a.m. with a Prayer by Magistrate Rick Wyatt, and the Pledge to the American Flag.

The Union County Fiscal Court met in a regular scheduled meeting with Magistrate Jerri Floyd presiding. The Union County Fiscal Court met in the upstairs Courtroom. Magistrates present were Wyatt, Ricketts, Jones and Girten.

The minutes from the July 25, 2023, Fiscal Court Meeting were approved as presented.

Court opened with Magistrate Jim Ricketts honoring four of Union County's top wrestlers. He first introduced Jordyn Raney, who won a gold medal/world championship at the 2023 17U Greco-Roman 55kg World event for Team Kentucky, held in Istanbul, Turkey. Also honored were Jayden Raney, who earned a championship title at the National Wrestling Championship in Fargo, ND. Lucas and Gavin Ricketts, Jim's grandsons, earned All-American wrestling status in Fargo, as well. Magistrate Ricketts, and the rest of the Court, commended the wrestlers not only for their accomplishments and dedication to wrestling, but also for their character, leadership, academic achievements, and the quality of citizens that they are.

Magistrate Wyatt made a motion to continue with advertising for bids on (2) Sheriff's vehicles. The ad was run on August 2 and will run again on August 9, 2023. Bids will be accepted until 9 A.M. Tuesday, August 22 at which time they will be opened in Fiscal Court. This motion was seconded by Magistrate Jones, motion carried.

Magistrate Jones made a motion to continue with advertising for a heavy equipment operator/truck driver at our Road Department. The ad was run on August 2 and will run again on August 9, 2023. We will stop accepting applications on Wednesday, August 16 and bring a recommendation before the Court on Tuesday, August 22, 2023. Magistrate Girten seconded the motion, motion carried.

Magistrate Wyatt made a motion to move seasonal worker, Justin Mosley, to full-time assistant mechanic at \$18.25 an hour, seconded by Magistrate Girten, motion carried.

Magistrate Ricketts made a motion to approve the Procurement Policy for Purchases Made with American Rescue Plan Act State and Local Fiscal Recovery Fund Monies, seconded by Magistrate Jones, motion carried.
